1. Recommendation to the Supervisory Board of INTERSPORT Polska S.A. of WL Finanse sp. z o.o. with the seat in Krakow as the entity to act as the chartered auditor authorized to review the half-year financial statement of the Company.
2. Recommendation to the Supervisory Board of INTERSPORT Polska SA of WL Finance sp. z o.o. with the seat in Krakow as the entity to act as a chartered auditor authorized to review the financial statements of the Company for the period from 1 January 2013 to 31 December 2013 .
3. Introduction to the work of the charter auditor and the report it prepared for the period from 1 January 2013 to 31 December 2013 .
4. Conducting discussions on:
 - a) current situation of the Company and the evaluation of risks associated with its activities ;
 - b) report on the operations of the Company for the year 2012 ;
 - c) financial statements of the Company for the year 2012.
